## DESCRIPTION OF SERVICES / FEE SCHEDULE

ABLE, Inc accepts multiple forms of insurance, however some policies do not cover ABA therapy. If services are sought out with no insurance coverage, the following rates will apply. Effective March 1, 2016.

Service	Description	Provided By	Rate
<b>Behavior Analysis Assessment/ Behavior Plan</b>	A Behavior Analysis Services Plan (BASP) is developed using information gathered from an assessment interview form, observations, interviews, and data. Problem behaviors and skill deficits are identified, the function of the behaviors is determined and what is maintaining the behaviors is identified. This plan will include the above information, defined behaviors, short and long term goals as well as procedures for reducing target behaviors and teaching replacement behaviors and/or skill acquisition. If an assessment determines that a behavior plan and continuation of services are not needed, rate will be adjusted accordingly.	BCBA or BCABA	<b>\$350</b>  Includes initial two hour visit, analyzing and interpreting information and data gathered, development of assessment and behavior plan *Initial interview paperwork should be completed before first visit
<b>Behavior Analysis Services</b>	Write functional assessments and behavior programs for disabled children and adults. Train and monitor parents and staff on the procedures described in the behavior plan. Run procedures in behavior plan as well as discrete trial training and task analyses for skill acquisition. Train, observe and monitor behavior assistants.	BCBA  BCABA	<b>\$75/hr</b>  <b>\$50/hr</b>
<b>Behavior Assistant Services</b> (if available)	Run procedures in behavior programs as well as discrete trial training and task analyses for skill acquisition. Work with clients and train staff and parents on the procedures described in the behavior program.	RBT	<b>\$25/hr</b>
<b>Planning and Interpretation of Data</b>	1 hour per month is designated to develop programming, gather or create materials, and provide graphic displays of data being recorded.		*Billed at the rate of the provider*
<b>Program Revision and Updates</b>	Bi-annually, a maximum of 2 hours will be billed towards the revision behavior plans put in place.		*Billed at the rate of the provider*
<b>Supervision</b> (if applicable)	If you are receiving services from a BCBA or BCABA <b>AND</b> a Behavior Assistant, one hour of supervision per month will be billed at either the BCBA or BCABA hourly rate only.	BCBA  BCABA	<b>\$75</b>  <b>\$50</b>

- Charges may apply if the location of service exceeds 30 miles from the location of the analyst.
- Please notify therapist **24 hrs in advance for cancellations** whenever possible. If the therapist arrives at the house/destination for a scheduled appointment and individual receiving services is not there, you will be **charged for a ½ hour**.
